### **Competition Class**

Evidence of prior experience or satisfactory completion of a high performance driver-training course is a Club requirement for the timed competition classes.

All competitors will require a dorian transponder to be fitted to their cars for official times to be recorded. Please make sure they are properly fitted and charged. Dorians can be hired for the day, but must be booked at time of entry.

### **Entrée Class**

Like to have a drive on the track, but don't want to run with the "Hot Shots"? Entrants in the entrée class get separate sessions of un-timed practise. You can even have an instructor in the car if you prefer (instructor must be an entrant on the day). No advanced driver training, fire extinguishers or dorians are required. All you need is a CAMS Level 2S License, an approved helmet, suitable clothing (see sup regs) and a roadworthy vehicle. This is the perfect introduction to track days for new members. Please note Entrée Class numbers are strictly limited. **Half Day in Entrée Class with Half Day as Marshal is also available.**

**All Entrants Note: 75dB(A) noise level will be strictly enforced by the venue.**

**Catering will be available at the venue.**

### 1. Authority

- The event will be a Club Supersprint held under the International Sporting Code of the F.I.A., the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the Speed Event Standing Regulations, the Non-Competitive Speed Event Standing Regulations (Familiarisation Session), the Passenger in Vehicle Guidelines, the 2009 P.C.V. Standing Competition Regulations, these Supplementary Regulations, and any Further Regulations which may be issued. The event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at [www.cams.com.au](http://www.cams.com.au).
- The event will be a multi car sprint conducted at Phillip Island Grand Prix Circuit over 4.45km in an anti-clockwise direction.

### 2. Entries

- Must be lodged with the event Secretary. Faxed entries with credit card payment will be accepted to fax number 9391 5911.
- In accordance with NCR83, the competition committee reserves the right to refuse an entry without explanation.
- No entries shall be accepted from under 18 year old competitors.
- A maximum of 90 entries will be accepted and in order of receipt on a correctly completed entry form.
- Entry fee is as stated on the entry form
- Entries open and close at the times/dates as stated on the entry form.
- All competitors must have registered to get their Cars scrutinised by 08.45 hrs on the day of the sprint.
- Entry to the event is conditional upon assisting on the day as and when requested by the organisers.
- Competitors must produce their current Porsche Club Victoria membership card and current CAMS L2S licence, Logbook and Competition Record at registration.

### 3. Vehicles

- Cars presented to the scrutineer not ready for competition will be denied entry to the event.
- Logbooks (if issued) must be presented at scrutiny.
- Cars must comply with Section 6, Schedules A and B of the CAMS 2009 Manual of Motor Sport & P.C.V. 2009 Competition rules.
- Tyres must be roadworthy and comply with P.C.V. 2009 competition rules.
- Open, M1 & M2 Class cars must comply with the CAMS Manual of Motor Sport, Schedule E - Wheel and Tyres,
- Clause 3 - Wet Weather Tyres
- Competition cars may be selected for Dyno and/or Weight testing.
- Competition cars must be fitted with a Dorian transponder, as timing will be by electronic means only. Dorians may be hired from PCV on the day check the entry form for information. Competitor in Entrée Class only will not be timed and dorians are not required.
- Maximum Noise not to exceed 75db(A) as measured by 30-Metre drive by test on equipment provided by circuit.
- Eligibility Committee may check and rule on the eligibility of your car as registered and entered on the day. Failure to comply may lead to disqualification from the entered event.

### 4. Apparel

- **Open 1, M1, & M2 Class competitors must wear driving suits in accordance with CAMS Manual of Motor Sport, Schedule D - Apparel Clause 3 - Clothing (i) Races.** All other competitors must wear neck to ankle wrist non-flammable clothing.
- Helmets must carry a standard as listed in Schedule D of the current CAMS Manual.

### 5. Event

- Cars will be released onto the circuit in pairs at 5 second intervals.
- Drivers are not to refuel in pit lane, starting or dummy grids
- A maximum of 18 cars will be permitted on the circuit at any one time.
- Drivers must obey flag and board signals.
- Drivers must run in numerical order unless otherwise instructed by an official.
- Protests, if any, must be submitted in writing to the Stewards or Clerk of Course in accordance with Part XII of the NCR.
- Results posted on the day are provisional only and are subject to further checking.
- Vehicles will not be permitted on the circuit after 4.30pm and must have vacated the complex by 5.00pm.
- During driver familiarisation only entered drivers and experienced competitors will be permitted in vehicles as passengers, subject to bone-fide instructors signing the appropriate indemnity form. All occupants must have at least Level 2S licences. Vehicles are to be driven at 80% of race pace. Passengers will not be permitted in vehicles during any part of the Supersprint.
- Awards for the event will be as per the 2009 P.C.V. Rule Book.
- The Porsche Club of Victoria reserves the right to take appropriate legal action, and to recover damages.

### 6. General

- In accordance with NCR59, the Promoter reserves the right to postpone, abandon or cancel the event at any time.
- Insurances will be provided in accordance with Appendix 1 of the CAMS Manual.
- During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s). The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.
- Fuel must be in accordance with Schedule G of the CAMS Manual and will not be available at the event.
