1. Authority

- The event will be a Club Autotest Special Event and Special Skills Event conducted on the Attwood Police Driver Training Complex skid pan and road circuit, held under the International Sporting Code of the F.I.A., the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the Speed Event Standing Regulations, the Touring Road Event Regulations, Non Competitive Speed Event Regulations, the 2010 P.C.V. Standing Competition Regulations, the Passenger in Vehicle Guidelines, these Supplementary Regulations and any Further Regulations which may be issued. The event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at www.cams.com.au.

2. Entries

- Faxed entries with credit card payment will be accepted to fax number 9391 5911.
- In accordance with NCR83, the competition committee reserves the right to refuse an entry without explanation.
- A maximum of 60 entries will be accepted and in order of receipt on a correctly completed entry form.
- No entries shall be accepted from under 18 year old competitors.
- Entry fee is as stated on the entry form.
- Entries open and close at the times/dates as stated on the entry form.
- **All competitors must have registered to get their Cars scrutinised by 08.45 hrs on the day of the event.**
- **Entry to the event is conditional upon assisting on the day as and when requested by the organisers.**
- Competitors must produce their current Porsche Club Victoria membership card and current CAMS L2S licence, Logbook and Competition Record at registration.

3. Vehicles

- Cars presented to the scrutineer not ready for competition will be denied entry to the event.
- Cars must comply with Section 6, Schedules A and B of the CAMS Manual of Motor Sport & P.C.V. 2010 Competition rules.
- Tyres must be roadworthy and comply with P.C.V. 2010 competition rules.
- Competition cars may be selected for Dyno and/or Weight testing.
- Log books (if issued) must be presented at scrutiny

4. Apparel

- All drivers and passengers must wear neck to ankle to wrist non-flammable clothing.
- Helmets must carry a standard as listed in Schedule D of the CAMS Manual.

5. Event

- The Special Test will be held on a bitumen road with chicanes positioned to make no leg more than 200 metres. The skid pan will be held on a specifically built skid pan. Cars will undertake tests one at a time.
- Drivers are not to refuel in pit lane, starting or dummy grids
- Drivers must obey flag and board signals.
- Drivers must run in numerical order unless otherwise instructed by an official.
- Protests, if any, must be submitted in writing to the Stewards or Clerk of Course in accordance with Part XII of the NCR.
- Results posted on the day are provisional only and are subject to further checking.
- Vehicles will not be permitted on the circuit after 4.00pm and must have vacated the complex by 4.30pm.
- During driver familiarisation passengers will be permitted in vehicles subject to signing the CAMS "Passenger in Vehicle Indemnity Form. Passengers must be properly attired. Passengers under the age of 18 will be allowed at the Clerk of Course's discretion and must have a parent/guardian sign then relevant disclaimer.
*Note: Passengers are not covered by CAMS insurance.
- Passengers will not be permitted in vehicles during any part of the skid pan or special event.
- Awards for the event will be as per the 2010 P.C.V. Rule Book.
- The Porsche Club of Victoria reserves the right to take appropriate legal action, and to recover damages.

6. General

- In accordance with NCR59, the Promoter reserves the right to postpone, abandon or cancel the event at any time.
- Insurances will be provided in accordance with Appendix 1 of the CAMS Manual.
- Use of prohibited Substances
- During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s). The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.
- Fuel must be in accordance with Schedule G of the CAMS Manual and will not be available at the event.
- Vehicles will be classified as per PCV Standing Competition Regulations.
- Results will be determined by the total cumulative times on all runs.
- Observers will act as judges of fact.
