## ***BRYANT PARK HAUNTED HILLS (MOE) HILL CLIMB***

**We were amongst the first to drive on the brand new Haunted Hills tracks last year, and we had a ball.** Forget about the short runs at Morwell, this is 1.2km in length with heaps of rise and fall. Built at a cost of approx \$3 million, it will rank as one of the great hill climbs in the world. There is also great spectator viewing, so bring the family along. The large Tag Heuer timing display in public view ensures plenty of competitive spirit and spectator engagement.

**Competition Class** - Evidence of prior experience or satisfactory completion of a high performance driver-training course is a Club requirement for the timed competition classes. All competitors must submit a 2009 Vehicle Registration Form prior to this event (if it is their first event for 2009) to be eligible for points.

**Entrée Class** – Want to have a run but not actually be timed? If so enter our Entrée Class. You can even have an instructor in the car if you like (instructor must be an entrant on the day). No advanced driver training, fire extinguishers or battery markers are required. All you need is a CAMS Level 2S License, an approved helmet, suitable clothing (see sup regs) and a roadworthy vehicle. This is the perfect introduction to Club Competition events for new members. Please note Entrée Class numbers are strictly limited. Half Day in Entrée Class & Half Day as Marshal is also available for \$75.

### **Directions**

### 1. Authority

- The event will be a Club Speed event Hill Climb conducted at the Haunted Hills Facility held under the International Sporting Code of the F.I.A., the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the Speed Event Standing Regulations, the 2009 P.C.V. Standing Competition Regulations, these Supplementary Regulations, and any Further Regulations which may be issued. The event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at [www.cams.com.au](http://www.cams.com.au).

### 2. Entries

- Must be lodged with the event Secretary. Faxed entries with credit card payment will be accepted to fax number 9391 5911.
- In accordance with NCR83, the competition committee reserves the right to refuse an entry without explanation.
- A maximum of 80 entries will be accepted and in order of receipt on a correctly completed entry form.
- No entries shall be accepted from under 18 year old competitors.
- Entry fee is as stated on the entry form.
- Entries open and close at the times/dates as stated on the entry form.
- **All competitors must have registered to get their Cars scrutinised by 08.45 hrs on the day of the event.**
- **Entry to the event is conditional upon assisting on the day as and when requested by the organisers.**
- Entrants must produce their current Porsche Club Victoria membership card and current CAMS L2S licence, Logbook and Competition Record at registration.

### 3. Vehicles

- Cars presented to the scrutineer not ready for competition will be denied entry to the event.
- Cars must comply with Section 6, Schedules A and B of the CAMS Manual of Motor Sport & P.C.V. 2009 Competition rules.
- Tyres must be roadworthy and comply with P.C.V. 2009 competition rules.
- Competition cars may be selected for Dyno and/or Weight testing.

### 4. Apparel

- **Open 1, M1, & M2 Class competitors must wear driving suits in accordance with CAMS Manual of Motor Sport, Schedule D - Apparel Clause 3 - Clothing (i) Races.** All other competitors must wear neck to ankle to wrist non-flammable clothing.
- Helmets must carry a standard as listed in Schedule D of the 2008 CAMS Manual.

### 5. Event

- **No private practise on the day will be allowed.** Competitors may be excluded from the results if found in breach.
- Drivers are not to refuel in pit lane, starting or dummy grids
- Drivers must obey flag and board signals.
- Drivers must run in numerical order unless otherwise instructed by an official.
- The event will be run in a clockwise direction and each driver will have a minimum of 2 runs. However, Stewards or Clerk of Course may alter this if necessary.
- Protests, if any, must be submitted in writing to the Stewards or Clerk of Course in accordance with Part XII of the NCR.
- Results posted on the day are provisional only and are subject to further checking.
- Vehicles will not be permitted on the circuit after 4.00pm and must have vacated the complex by 4.30pm.
- Passengers will not be permitted in vehicles during any part of this event.
- Awards for the event will be as per the 2009 P.C.V. Rule Book.
- The Porsche Club of Victoria reserves the right to take appropriate legal action, and to recover damages.

### 6. General

- In accordance with NCR59, the Promoter reserves the right to postpone, abandon or cancel the event at any time.
- Insurances will be provided in accordance with Appendix 1 of the CAMS Manual.
- During any competition, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Procedure for Alcohol Testing and CAMS Drugs in Sport Policy. Competitors, crews or officials may be tested for alcohol or other drugs at any times during the event(s). This regulation serves as the required 24-hour notice to Competitors, Crew and Officials.
- Fuel must be in accordance with Schedule G of the CAMS Manual and will not be available at the event.
